Australian Qualifications Framework (AQF)

The Australian education system is distinguished from many other countries by the Australian Qualifications Framework (<u>http://www.aqf.edu.au/</u>).

The AQF was established in 1995 and is a national policy that covers qualifications from the tertiary education sector (higher education and vocational education and training) in addition to the school-leaving certificate, the Senior Secondary Certificate of Education.

The AQF has 10 levels and links school, vocational and university education qualifications into one national system. This allows you to move easily from one level of study to the next and from one institution to another. It allows for choice and flexibility in career planning. All qualifications in the AQF help prepare you for both further study and your working life.

If you are studying an AQF qualification, you can be sure that your institution is government authorised and nationally accredited, and that your AQF qualification will be genuine.

Australian institutions are linked across the country and across the world, which makes it easy to move throughout the education system between courses or institutions and formal agreement and recognition frameworks mean every step of the path will contribute to your future no matter what your study or career goals.

Lawson College Australia accredited qualifications are aligned with the Australian Qualifications Framework (AQF) and approved by the Vocational Education and Training (VET) accreditation authority, Australian Skills Quality Authority (ASQA).

Location

Dandenong is a suburb of Melbourne approximately 30 km south-east from central business district. Situated alongside the Dandenong Creek, it is at the foothill of the Dandenong Ranges.

Lawson College Australia is located in the heart of Dandenong. This area offers a uniquely diverse range of opportunities in a growing and vibrant economy, all within the world's most liveable city. It is a crucial and dynamic business hub for Australia and Victoria. Living, studying and working in this dynamic growth corridor provides you plenty of opportunities in a range of growing and established industries.

Lawson College Australia has two campuses in Dandenong:

- 2/228 Lonsdale Street, and
- 53 Walker Street

Students have easy access to Dandenong from surrounding suburbs with an excellent train and bus service. The Lawson College Australia premises are a short walk from the Dandenong Railway Station. A bus service stop is accessible at the rear of the Lonsdale Street premises.

Parking

The City of Greater Dandenong Council manages street parking and also owns and operates a number of car parks across the municipality, including four <u>multi-deck car parks</u>. https://www.greaterdandenong.vic.gov.au/parking-roads-and-transport/parking

Parking signs in each location tell you if there is a time limit and if payment of a fee is required. The word 'ticket' on a parking sign indicates that you must buy a ticket from a ticket machine, and display it clearly on your dashboard.

Parking restrictions within the municipality are frequently reviewed to ensure that they are appropriate for access and convenience.



Facilities



Lawson College Australia facilities include a library/computer lab; lecture and tutorial rooms; skills laboratory; tea room and student lounge. The 'common room' provides students an ideal area within the building to relax, socialise with other students and have their meals.

Students also have full access to fridges, kettles, microwaves, toaster ovens and sandwich presses. This allows students to bring food from home and save money. Appropriate toilet facilities (including disabled toilet) are available in the premises.

Lift access is available at Lonsdale Street premises, and ground floor training environment is available at Walker Street premises.

Classrooms

All classrooms are equipped with cooling and heating facilities. Classrooms are furnished with comfortable and appropriate furniture and equipment to foster effective learning.

Computers and laptops

To study at Lawson College Australia, you will be required to have access to your own personal laptop computer and the internet. Internet (free Wi-Fi) services and access to generic desktop computers are available on-campus. Printing/scanning facilities are also available in the computer lab.

Library

The Lawson College Australia library is equipped with an excellent selection of textbooks. Students can borrow books, use the photocopier and the adjacent Study area for personal study.

Personal care skills laboratory for community services programs

Safety, Health, and Wellbeing

Lawson College Australia complies with Government and Regulatory guidelines regarding safety, health and wellbeing.

Lawson College Australia has a number of processes to provide a safe and secure learning environment to all students. These include hours of operation and access to staff to assist students where required.

When travelling to and from Lawson College Australia premises it is important to ensure your own safety at all times.

In an emergency call Triple Zero 000

Student safety tips:

- Don't openly carry valuables, including expensive gadgets, mobile phones, laptops, etc
- Find suitable and safe routes to petrol stations, shops and your local police station.
- Try to find routes that are well lit and busy
- Avoid confrontation it is better and safer to walk away if you are being provoked
- If you feel you are being followed, cross the street, and if you are still worried, move as quickly as possible to a public area (such as a restaurant) and then telephone for help
- At night, walk in pairs in well-lit areas and on busier streets, not dark alleyways and side-streets
- Have your keys ready well before you reach the door of your car or house
- If you are going away, tell someone you trust where you are going and when you will be back
- If travelling by bus or tram at night, try not to wait alone at the bus or tram stops
- Arrange for others to meet you at your home stop if you are returning late and have a long way to walk home
- If you are travelling by train at night, do not sit in an empty carriage. Try to sit near groups of people in a well-lit area
- Check the time of the last train, bus or tram home to avoid being stranded at night
- Avoid walking alone after getting off public transport at night. If you can, walk close to a group of people or arrange for someone to meet you.

Smoking is not permitted in Lawson College Australia premises.



Lawson College Australia Programs

Lawson College Australia provides students with a range of options to work towards nationally accredited VET courses and offers diverse career options in the industry. Students acquire a range of skills and knowledge to work effectively in their chosen field of work. Lawson College Australia regularly engages with industry to conduct consultation to ensure that their courses meet industry standards.

Lawson College Australia offers the following qualifications:



Competency-Based Training and Assessment Process

Competency-based training is an approach to vocational education and training that places prominence on what a person can do in the workplace as a result of completing a training program and ensures that vocational education and training programs better meet the needs of Australia's workplace needs. Delivery of training occurs before assessment, to ensure understanding of the skills and knowledge required to undertake certain work roles. Assessment is the process of collecting evidence and making judgments on whether competency has been achieved and confirm that an individual can perform to the standard expected in the workplace, as expressed in the relevant endorsed industry or enterprise competency standards.

Assessments at Lawson College Australia require students to complete a variety of assessment tasks, for example, but not limited to, written questions and other written tasks such as reports, projects, presentations and where applicable, practical demonstrations.

Where a student has undertaken an assessment and it has been marked as NYC (Not Yet Competent), they are permitted re-assessment, as per Lawson College Australia's Policy and Procedures. If they are deemed NYC after re-assessment a student may re-enrol into that unit/ subject. Fees and charges will apply.

The VET Student Loans (VSL) program assists eligible students pay tuition fees (up to a capped amount) for approved higher-level (diploma and above) vocational education and training (VET) courses, when studying at VET Student Loans approved course providers.

VSLs are only available for approved courses at the diploma level and above. This means that you cannot get a VSL for a Certificate IV level course or below.

There is a limit to how much you can borrow, called the 'loan cap'. The loan cap amount is different depending on the course you study.

Some providers may offer courses that cost more than the loan cap. In these cases, students must pay the difference between the course cost and the loan cap.

You repay that loan through the tax system when your income exceeds a repayment threshold determined by the Australian Government.

The Australian Tax Office will calculate your compulsory payments each year and collect these payments until the whole debt has been repaid.

Depending on your income, the VET Student Loan can result in a reduction of your take-home pay and borrowing capacity.

Students should seek independent financial advice before committing to the VET student loan.

To remain eligible for the VSL scheme:

- your course must continue to remain on the approved list of VSL courses.
- you must confirm your engagement and progression online when requested to by the government, otherwise, you may cease being eligible for a VSL.

If you do not meet the eligibility requirements you will not be able to access a VET Student Loan but you will still be able to study in your course if you meet the course entry requirements and pay your tuition and other applicable fees.

What is covered by VSL

VET Student Loans (VSL) can be used to cover tuition fees only. Other fees, e.g., student services fees, material fees, tours or excursions, are not covered.

For most courses, the VET Student Loans (VSL) cap will not fully cover the tuition fees for the entire course. You will be required to pay any tuition fee above the loan cap as it becomes due. You will also be required to pay any other non-tuition fees (excursions, uniforms, etc) before you can commence study.

Loan Fee

There is a loan fee for Full-Fee Paying/Fee For Service students calculated at 20% of the loan amount which is added to the loan balance.

If the Department of Education and Training removes your course from the list of eligible courses, the remainder of tuition fees for the rest of your course will no longer be covered.

The Department of Education and Training sets a limit on the total amount of student loans allowed for each education provider and this limit may not cover all eligible student loans.

Eligibility for a VSL

Individuals are eligible for a VET Student Loan if they:

- are enrolled in a VET Student Loans approved course offered by a VET Student Loans provider
- meet citizenship/residency requirements
- have an available HELP balance of more than \$0 (that is, have sufficient HELP balance remaining)
- meet student entry requirements.

Eligibility – Australian citizenship

- Evidence of Australian citizenship
 - Documentation that is acceptable:
 - Current passport
 - Birth Certificate (pre 20/08/1986)
 - For students born after 20/08/1986, if their Australian birth certificate shows one of their parents was born in Australia (before 20/08/1986), this is sufficient for citizenship eligibility for VSL purposes.
 - Citizenship Certificate
 - To be noted, Medicare care and/or Drivers Licence *is not* sufficient to prove citizenship status.

Eligibility - other citizenship

- New Zealand Special Category Visa (SCV) holders
 - Usually been resident in Australia for at least 10 years,
 - Were a dependent child when first began residency in Australia,
 - o Have been in Australia for periods totalling eight years during the previous 10 years, and
 - Been in Australia for periods totalling 18 months during the previous two years.
 - To be noted: If the first time a NZ citizen came to Australia was at the age of 19, they <u>will not</u> be eligible for VSL.
- Permanent Humanitarian Visa holders
- To be noted, Permanent Residents are not eligible for VSL.

Tax File Number

When you apply for a VET Student Loan you need to provide your Tax File Number (TFN) because repayments of your loan are made through the tax system. If you don't have a TFN you must apply to the <u>Australian Taxation</u> <u>Office</u> (ATO) for a TFN. It is best to have your TFN before you enrol to ensure you can access a loan for your studies.

ENROLMENT PROCESS

Once an applicant has determined that Lawson College Australia offers the course that will satisfy their needs and career plan, they should carefully read through the entry requirements to determine if they are eligible to apply.

STEP 1

Complete an Enrolment Form – Domestic Student

Once the applicant has established their eligibility for the course, they should complete the enrolment process. A form is available on request, or it can be downloaded from our website http://lawsoncollege.edu.au/applying/.

The completed enrolment form together with all supporting documents should be emailed to <u>admissions@lawsoncollege.edu.au</u>.

STEP 2

Apply for Course credit

All applicants have the opportunity to apply for course credit. Individuals can apply for course credit during the time of enrolment.

- 1. If a student wishes to apply for course credit they must complete the 'Course Credit Application' document with the required information (such as detailed records of their experience, employment, training, etc., which may be relevant).
- 2. The 'Course Credit Application form' will specify the units to be completed and students will be required to identify how they address the elements of each unit included in the Course Credit Application.
- 3. Once the Course Credit Application form is completed, they are required to submit this with associated evidence to the student administration. This Course Credit Application and evidence is to be assessed by an assessor and the student is to be notified of the outcome.

Students can get access to the RPL application form by sending an e-mail to <u>admissions@lawsoncollege.edu.au</u>. For further information on the credit transfer/RPL process please refer to RPL policy and procedure in Section 3 of this handbook.

STEP 3

Enrolment documents verification procedure

Lawson College Australia will assess whether the student's meets the entry requirements for the course for which enrolment is sought. All relevant documents provided by the student will be assessed and verified by the Qualification and Admission Team. An enrolment information checklist will be completed for each application received.
