

Factsheet - Scholarship

Does Lawson College Australia offer scholarships and if yes, how do I apply and what are the implications of being awarded a scholarship?

Scholarships are awarded to eligible students in the form of a Fee Waiver or Fee Discount.

Details of the amount of the Scholarship will be/is outlined in your Letter of Offer and Written Agreement and is awarded at the sole discretion of Lawson College Australia.

There is no application process by the student.

| Scholarship (Fee waiver, Fee discount) | <p>A reduction in the tuition fee to support student's education for the entire duration of a course or courses selected by the student with a minimum of 2 years of study, as offered by LCA.</p> <p>A scholarship includes fee waiver, fee discount and is offered to students who apply for admission directly to Lawson College and not through any agency.</p> <p>Students applying through an agency are generally not eligible for scholarship.</p> <p>A scholarship, fee waiver and fee discount are offered to the eligible students on the conditions that the student will continue studying with LCA for the entire duration of the course or courses for which the scholarship, fee waiver or fee discount was initially offered and timely payments of all the fees, including the tuition fee, as mentioned, and accepted by the student on the 'Student Written Agreement' also called as 'Letter of Offer'</p> |

Implications of a Scholarship

- a. Scholarships provide invaluable support and financial assistance to eligible students.
- b. Spent (used) scholarship is normally required to be paid back to Lawson College Australia in certain situations as outlined in the table below.

| Spent (used) Scholarship | <p>At LCA a 'spent scholarship' amount relates to the amount a student has 'used' during their enrolment and is required to reimburse (pay back) LCA if a student cancels their enrolment or transfers out of LCA prior to completion of the final six months of the 'Principal Course'. The 'spent scholarship' is determined by calculating the amount of scholarship 'spent' (used) during enrolment in a course currently enrolled. The spent scholarship amount is the difference between the full instalment fee less the amount actually paid (as per the scholarship awarded).</p> <p><i>A Spent Scholarship is normally required to be paid back to LCA.</i></p> |
